Zero Dollar Listings, LLC operates zerodollarlistings.com ("Site").

The owners and agents of Zero Dollar Listings know what it's like to have continual unsolicited contact from companies trying to sell their product. We respect the privacy of each user of our Site (referred to as "you" or "user"). We respect your privacy whether you have just started your search to buy or sell a home or whether you are already our client. This Privacy Statement gives you specific detailed information about how we protect your privacy and how we treat information on the Site that is given to us by you.

BY REGISTERING FOR OR USING THE SITE, YOU SIGNIFY YOUR ACCEPTANCE OF THIS PRIVACY STATEMENT. IF YOU DO NOT AGREE TO THIS PRIVACY STATEMENT, YOU CANNOT USE THE SITE. We reserve the right to modify this Statement at any time by posting a notice on the Site's home page. Your use of the Site after the date of the last modification listed at the beginning of this Privacy Statement indicates to us that you agree to the changes.

Location of Servers and Transfer of Information to the United States

The Site is hosted by servers at ipage.com. If you are located outside of the United States, your Personal Information will be transferred to the United States. By submitting your Personal Information, you consent to its transfer to the United States and to its storage, processing, and use there in accordance with this Privacy Statement.

Scope of this Privacy Statement

This Privacy Statement applies to your use of this Site only. We do not own, operate or control the web sites of our sales associates. Accordingly, this Statement does not apply to a sales associate's web site or to a sales associate's collection, use, storage and disclosure of your Personal Information.

1. Collection and Use of Your Personal Information

We collect your Personal Information on the Site only to provide you with necessary information to help you with buying or selling real estate. We collect Personal Information from you only when you voluntarily submit it in order to obtain certain services or information, including (A) registrations for special communications, such as saving a search for you and, but only if you request it, sending you new listings that fit the profile of your saved search; (B) requests to find a property, to list your property, to find a sales associate and to schedule an in-house appointment; (C) requests to contact us; and (D) requests to receive periodic industry updates.

Requests to Find or List a Property and to Find a Sales Associate

If you submit a request through this Site to find or list a property, to schedule an appointment or to find a sales associate, you will be asked to provide Personal Information and we refer this information to sales associates to respond to your request.

Requests for Information

If you submit a request through this Site for information on buying or selling real estate you will be asked to provide Personal Information so we can provide you with the information you requested and we can follow up with you to determine if you can use our other services. This follow up can be either by email or phone.

Contacting Us

If you contact us, we collect Personal Information, which is retained or referred to a sales associate depending on the nature of your inquiry. If you are looking for a property or a sales associate, it is referred to a sales associate; if your inquiry or complaint requires a response from us, it is referred to site ownership for a response. The information we collect is not used in any other way.

2. Collection of Non-Personal Information

We do not collect information about how you use our site ("Non-Personal Information"). The use of the site cannot be used to identify you personally.

Cookies

A cookie is a small data file, often including an anonymous unique identifier, that is sent from a web site's computer and stored on your computer's hard drive. Use of cookies is common on the Internet. zerodollarlistings.com does not use cookies.

ZeroDollarListings.com uses Google AdWords and other remarketing services to advertise on third party websites (including Google) to previous visitors to our site. It could mean that we advertise to previous visitors who haven't completed a task on our site, for example using the contact form to make an enquiry. This could be in the form of an advertisement on the Google search results page, or a site in the Google Display Network. Third-party vendors, including Google, use cookies to serve ads based on someone's past visits to other websites. Of course, any data collected will be used in accordance with our own privacy policy and the privacy policies of the websites for the remarketing services.

For visitors who do not want cookies stored on their computer they can opt out of Google's use of cookies by visiting Google's Ads Settings or by visiting the Network Advertising Initiative opt-out page.

3. Use of Information

We use the Personal Information we collect on the Site (A) to provide you with the services that you ask to receive through the Site, (B) to receive, if you choose, to receive periodic industry updates, (C) to answer your questions or complaints, (D) to refer you to sales associates about finding or listing a property or to locate a sale associate.

We may also use the Personal Information to inform you about other services and products that may be available through us and to provide you a customer survey to assess your satisfaction with our services and products.

We may allow others to provide audience measurement and analytics services for us, to serve advertisements on our behalf, and to track and report on the performance of those advertisements. These entities may use cookies, web beacons, SDKs, and other technologies to identify your device

when you use the Site, as well as when you visit other online sites and services, and such services will be covered by the privacy policy of the respective third parties.

We use Google Analytics to collect information about use of the Site. More information on Google Analytics – including how you can control the information sent to Google - can be found here:www.google.com/policies/privacy/partners.

4. Sharing Your Information

We will never share your personal information with anyone not affiliated with Zero Dollar Listings, LLC. Information collected on our site may be sent to a sales associate to contact you about using our products and services.

5. Security

Our hosting services maintains its systems in accordance with reasonable industry standards to reasonably secure the information of its customers. However, no data transmission over the Internet can be guaranteed to be 100% secure. "Perfect security" does not exist on the Internet, and you use the Site at your own risk.

6. Correction/Updating Personal Information

If your Personal Information changes or if you no longer wish to use the Site, you may correct or update your Personal Information or unsubscribe from any industry updates you have requested by modifying or deleting your profile on the Site, writing to customer service at **david@davidmaisch.com**

7. Children

This Site is not directed to children under the age of 17 ("Children"), and we do not knowingly collect any information, including Personal Information, from Children.

8. California Privacy Rights
